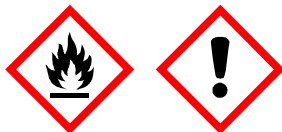

Section 4. First aid measures

- Specific hazards arising from the chemical** : Runoff to sewer may create fire or explosion hazard. This material increases the risk of fire and may aid combustion. Heating may cause a fire. Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapor or mist. Use only with adequate ventilation. Do not enter storage areas and confined spaces unless adequately ventilated. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Store and use away from heat, sparks, open flame or any other ignition source. Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use only non-sparking tools. Conditions for safe storage, including any incompatibilities

: To avoid the risk of formation of shock-sensitive crystals or loss of stability, it is important to store the product within the recommended temperature range. Temperature control may be required. Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store at temperatures not exceeding 25 °C/77 °F. Eliminate all ignition sources. Separate from reducing agents and combustible materials. Keep away from rust, iron and copper.
