### Inhalation

If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. # Section 5. Fire-fighting measures

### Specific hazards arising from the chemical

# Section 7. Handling and storage

### **Precautions for safe handling**

### **Protective measures**
